- **b.** Werner/Hill moved to approved proposed members. Stephen Fuzei to be accepted as a communicator member. Approved.
- **c.** Werner/Hamrick moved to approve retired status for members requesting it. Motion carried.

- **d.** Two clubs want reciprocal agreements Bankers Club of Miami and National Press Club of New Zealand. Werner/Wojno approved.
- **4. Awards. Mike Soraghan/Werner** moved approval minus Friedheim travel and honorable mention for consumer reporting. There was a discussion as to whether these entries were eligible based on their publishers.

Greg Davis, chair of the judging panel for the Friedheim Travel award, addressed the board in favor of his panel's choice for the award. He had been advised that the choice might be ruled ineligible. He said that such a decision would be inconsistent, and rule out many other entrants commonly deemed to be eligible.

Werner noted that we cannot accept the nomination based on the current language in the policy; i.e., the rules must be rewritten to accept the award.

Hamrick: "We are not in the business of bending our own rules."

Hughes: We've been awarding Consumer Reports since the 1980s. The judges feel this is a good work of journalism that deserves to win.

Soraghan: The board determines eligibility.

Rodrigo: Given the fact that journalism is evolving, perhaps the policy should be changed.

Hughes/Wojno moved to amend the motion to accept Consumer Reports in with the full pack. Tie 6-6, motion failed.

Main motion passed.

5. Committee reports

a. Library board (Dunham).

There has been conceptual agreement regarding the Memorandum of Understanding for cost sharing between the Club and the Library, which is a NPC affiliate but a legally independent 501(c)(3) organization. The MOU is now with the lawyers before being presented to the board. We hope to have final MOU ready for next month's board meeting.

Boot Camp was very successful. Had about 65 attendees.

b. International Correspondents Committee (Myron Belkind)

Two events upcoming in June:

1. Panel Discussion on Islam, Pakistan and Faith-based Diplomacy June 23, 6 p.m. -- Washington Post journalist Sally Quinn will moderate a panel discussion at the National Press Club from 6-8 p.m. Thursday, June 23, on the role of faith-based diplomacy and using religion to resolve conflicts, including those involving Islamic extremists in Pakistan.

The event coincides with the publication of the book, 'Religion, Terror and Error: U.S. Foreign Policy and the Challenge of Spiritual Engagement,' by Dr. Douglas M. Johnston, President of the International Center for Religion & Diplomacy (ICRD).

Committee Vice-Chair Larry Quinn is spearheading this task and working with the archivist and the online team to select films, video, audio, photos and documentation based on themes specific to the Club's history and heritage. Content for the Web page will be added on a frequent basis. The Committee plans to have a working Web page up well before the end of the year.

The Committee is preparing for its Women in the Civil War panel program on September 19, 6:30 p.m.

Jonathan Salant and Heather Weaver have been trained as Wire editors and will start editing the Wire in the next couple of weeks. Chairman Schoeff would like to congratulate Donna for her work as editor -- a great help in ensuring the publication is produced and delivered on time.

Look for a huge party celebrating the success of internet media and the 5th anniversary of KStreetKate.net, DC's longest running online lifestyle magazine on July 27. It will be a blowout that should not be missed and is growing in awesomeness by the minute. Details will come soon.

Finally, we are excited to announce that the Young Members will be hosting and partnering with World Wrestling Entertainment, the National Education Association, The Creative Coalition, The Ad Council and GLAAD as a part of their B.A. Star Alliance to help end bullying. Look for more information on a large event that we will have coming in conjunction with the start of the school year in September.

h. Travel Committee (Keith Hill)

Fourteen members are signed up for the China, Silk Road & Tibet trip June 30-July 15.

The trip to the Civil War Manassas battlefield was terrific.

i. Book & Author (Ed Barks)

Rick Beyer and his book The Greatest Music Stories Never Told drew 40 people to the club on June 14, and sold out the stock of 20 books.

Upcoming events include former FEMA chief Michael Brown and his book Deadly Indifference: The Perfect (Political) Storm: Hurricane Katrina, The Bush White House, and Beyond on June 21. To date, 21 people have signed up. Neil Gaiman's book rap on American Gods: The Tenth anniversary Edition has sold out the ballroom and its 550 person capacity on June 23. Additionally, more

than 200 books have been pre-sold, making this a real bonanza for the Freidheim Library. Former Sen. Bob Graham is set to discuss Keys to the Kingdom on August 1.

Washington Post book critic Michael Dirda is a possibility for July, though the committee is monitoring other options that may arise.

Club and committee member Eleanor Herman will release King Peggy in February. Club staff plans to contact her publicist to get started for this event. Herman filled the ballroom when her last book was issued. Library staff is also talking with Dana Priest and William Arkin (Top Secret America: The Rise of the New American Security State) for a fall book rap.

In continuing efforts to reach out to younger members, the committee is investigating a possible book event featuring graphic novels. Numerous authors from that genre will be in Baltimore for Comic Con on August 20-21, so an event here either side of those dates will be pursued.

At the behest of Larry Lipman, the committee is reinvigorating its efforts to draw authors who appeal to children. Saturday events in years past with such high profile authors as J.K. Rowling and Brian Jacques were most popular. A list of potential drawing cards is being developed.

j. Communications & Marketing (Barks)

The committee's June 9 LinkedIn workshop, led by NPC member Anthony Shop, drew 18 attendees, capacity for the Bloomberg Room. Committee chair Tom McMahon and Vice Chair Martha Lockwood, who organized the session, commend club staff that organized, provided the technical expertise, and served breakfast. A post-event survey revealed that 87 percent felt that they had received the information that they were expecting, and an equal number felt that the content was on target. All said that it was a good value for their time and money spent.

The committee is working with United Way to sponsor a panel discussion on corporate social responsibility. The event is planned for the club on July 14 from 8-10 a.m. in the Bloomberg Room. The panelists are from Washington area companies discussing the programs they sponsor for the local community. Alex Orfinger, the publisher of the Washington Business Journal, will moderate the panel discussion. Panelists include:

k. Newsmakers (John Hughes)

- 1.) U.S. Rep. Scott Garrett, R-N.J., chairman of the House capital markets subcommittee, will discuss a bill that would give priority to repaying outstanding debt when the limit is reached, at a Newsmaker press conference at 2 p.m. tomorrow in the Zenger Room.
- 2.) A Newsmaker forum on the growing threat that counterfeit products pose to public health and safety, as well as the U.S. economy, will be discussed by a panel at 10 a.m. Thursday in the Zenger Room. The panel will feature experts from the U.S. Department of Homeland Security, Eaton Corp. and Pfizer Inc., and explore how government and industry can collaborate to combat this critical problem.
- 3.) We have scheduled U.S. Trade Representative Ron Kirk for July 7, and Taiwan Minister of Government Information Dr. Philip Yank for July 15.
- 4.) In the works are United Parcel Service CEO Scott Davis to discuss trade, jobs and oil; and U.S. Rep. Barney Frank (D-Mass.) to speak on the status of Wall Street reform legislation on its one-year anniversary, July 22.

- 3.) Put out a statement and participated in the hosting of an event June 6 on the murder of Pakistani journalist Syed Saleem Shahzad. President Mark Hamrick spoke, as did Pakistan's ambassador to the United States, Husain Haqqani.

m. Events Committee (Joel Whitaker)

1) Dinner and a Movie

In response to a dwindling crowd at "Dinner and a Movie Nights" the committee has responded to suggestions from Mesfin Meskonen to select more current films. For the June film, we chose "The King's Speech" and a record 15 members and guests attended. The committee will continue to choose popular films and seeks suggestions.

2) "Daring to Draw: An Evening with Political Cartoonists from Around the World." -- The committee partnered with the U.S. Department of State to host a cocktail reception with 20 political cartoonists from around the world, hosted at the Club tonight (June 20). More than 20 guests are expected.

Belkind: International Committee has cosponsored events with International Committee of Journalists. Excellent for us to cobrand, especially when other org is paying room rental.

McCarron: Only supposed to co-partner w/other journalism organizations. We haven't looked at professional development of communicators, but we should.
