MEETING OF THE NATIONAL PRESS CLUB BOARD OF GOVERNORS May 18, 2009 Myron Belkind, Secretary

Chair Jennifer Sergent called the meeting to order at 6:40 p.m. Present were President Donna Leinwand, Secretary Myron Belkind, Treasurer Keith Hill, Membership Secretary Mark Hamrick, Governors Dipka Bhambhani, Jessica Brady, Shawn Bullard, Gayela Bynum, John Hughes, Jennifer Sergent, Mike Soraghan, Theresa Werner, former presidents Sylvia Smith and Jerry Zremski and David Jones and Nancy Johnson of the Club's auditors, Ribis, Jones & Maresca. Also General Manager Bill McCarren, Director of Membership Jane Middleton, and Archivist Marlene Justsen. Absent were Vice President Alan Bjerga and Governor John Donnelly.

Belkind moved and the Board approved the minutes of the April 20 meeting.

INDEPENDENT AUDITORS' REPORT

David A. Jones and Nancy Johnson of Ribis, Jones & Maresca, the Club's independent auditors, presented their annual audit of the National Press Club, as of Dec. 31, 2008, to the Board of Governors and briefed its members on its contents prior to the Board formally voting on the Report at its next meeting in June. The auditors' representatives gave an "unqualified clear opinion" that the accounts were in order and said the Club is moving in the "right direction in generating profits from operations" and is "on the right track in building up reserves." The auditors also expressed their appreciation for the cooperation received from the Club's staff while conducting the audit.

DRAFT PHOTOGRAPHERS' COPYRIGHT AGRFEEMENT

The Board approved a draft agreement covering the relationship between the Club and the volunteer photographers who cover events for the Club's publications and other requirements. The document will next be reviewed by the Club's lawyer prior to presenting it to the photographers. Secretary Belkind, on behalf of Darlene Shields, chair of the Photography Committee, said the expanded number of volunteer photographers were doing excellent professional work and were enthusiastic about taking on assignments covering the Club's activities. Archivist Marlene Justsen, who is coordinating the assignment of the photographers with Darlene Shields, concurred that the arrangements with the volunteer works were working extremely well.

MEMBERSHIP

On the recommendation of Membership Secretary Mark Hamrick, the Board approved the application of 33 members (see list at end of Minutes), retired status for 15 members and a six-month dues waiver for 9 members. The number of new members so far this year is 191. Total members as of the Membership Report to the May Board meeting were 3,464 compared to 3,525 last year.

NEW RECIPROCAL ARRANGEMNTS APPROVED WITH TWO CLUBS

The Board of Governors, on the recommendation of Membership Secretary Mark Hamrick, approved new reciprocal relationships with two Clubs:

- The Athenaeum, a decades-old club with 4,000 members in Pasadena, California, which has three restaurants, overnight accommodations, an athletic center and tennis courts, and
- The Akron, Ohio, Press Club, with 155 members, which holds speaker luncheons, concerts and journalism seminars and provides scholarships to students in journalism and public relations.

COMMITTEE LIAISON REPORTS

Chairwoman Jennifer Sergeant proposed, and the Board accepted, that in view of the lengthy agenda for this meeting, that the Board's Committee Liaison reports as e-mailed to Secretary Myron Belkind be included in the Minutes for the May 18 meeting rather than having oral presentations by each Board Liaison to the respective committees.

HARVARD BUSINESS SCHOOL SURVEY

The Board approved a proposal by past president Jerry Zremski, as chair of the NPC Stategic Planning committee, for Prof. Roy Chua of the Harvard Business School to conduct a survey of Club members to help the Club leadership learn about members' professional networks and what they think about the future of the journalism business. President Leinwand will urge Club members to participate through articles in the Wire.

"The results will show us how much our members socialize and share information in their professional lives," she said. "In addition, this survey will give every member the opportunity to say what they think about the traditional news industry – and how it can be rescued from these troubled economic times."

As an incentive for members to take part in the survey, 10 of the participants will be randomly chosen as winners of \$100 gift certificates for use in the Club's restaurants. Harvard will pay all the costs of the survey and incentives.

Professor Chua is assistant professor in the organizational behavior unit at the Harvard Business School. Chua's research draws on social psychology to understand important social processes in business organizations.

BOARD APPROVES CHANGES TO NPC CONSTITUTION AND BYLAWS

The Board of Governors unanimously approved a series of \Box amendments to the Club's Constitution and Bylaws and recommended that the Club membership also approve them. The proposed changes grew out of the Club's \Box first five-year Strategic Plan approved at the General Membership Meeting on \Box May 8. \Box

A key Constitutional amendment provides for the addition of a third \Box Affiliate and Associate board seat in the December 2009 election. \Box The amendments will be discussed and voted upon at a special membership \Box meeting that was subsequently scheduled for Monday, July 13, at 6:30pm. \Box

Many of the other changes relate to updating the wording of the Constitution and Bylaws, including adding the Club's Mission Statement from the new Strategic Plan into the Constitution as the Club's main purpose in Article II and replacing references to the Record with "all other vehicles of commonly used communication" for purposes of notifying members when required including during the annual elections.

The changes were proposed by the Board's Constitution and Bylaws committee comprising of Chairwoman Jennifer Sergent, Secretary Myron Belkind, Associate/Affiliate Member Gayela Bynum and past President Sylvia Smith.

The Board also discussed a motion made by Bynum to provide full voting rights on the Board to the Affiliate/Associate members and full voting rights to Affiliates and Associates in the annual elections. \Box Meeting as a Committee of a Whole, the board, including the two Affiliate/Associates, voted 4-8 against the proposal following a discussion \Box in which several members said that particular proposal should first be considered and proposed by the Constitution and Bylaw Committee so that it can be brought to the full Board and the general membership once the initial amendments are approved. \Box

TREASURER'S REPORT

Treasurer Keith Hill reported that the Club made a profit of \Box \$61,139 in April, the fourth consecutive profitable month of the year. Total \Box profit for the first four months was \$519,000. \Box \Box Hill said that with May and June looking to be profitable, the Club \Box continues to be on target to have \$1 million in reserves by July 1 in \Box advance of anticipated losses in July and August. \Box

PRESIDENT TO START MONTHLY NEWSLETTER FOR MEMBERS NOT ONLINE

President Leinwand said she would write a monthly newsletter that would be sent to Club members who cannot read the online NPC Wire and no longer would be receiving the Record by mail following publication of its last regular issue on June 1.

NUMBERS GROW FOR SATURDAY SERVICE IN FOURTH ESTATE

The new all-day Saturday operations in the Fourth Estate Restaurant are proving popular, with members turning out for both brunch and dinner in good numbers, President Donna Leinwand reported to the Board of Governors. D Last Saturday, on May 16, 44 Club members came for brunch, including about 20 who attended the monthly Books & Brunch group that previously met in the Reliable Source, and 35 came for dinner.

General Manager Bill McCarren said the Saturday numbers were picking up \Box steadily from May 2, the first Saturday that the Fourth Estate was opened \Box for the entire day, when there were 11 members at brunch and six for dinner. \Box The following Saturday had 40 for brunch and 26 dinner. \Box \Box McCarren said that previously the best attendance in the Reliable Source for \Box a Saturday brunch without the aid of Books & Brunch was 19. \Box

Under the new arrangement, the Fourth Estate will be closed on Monday nights, a traditionally slow night, to accommodate dining on Saturday nights, normally a popular night out for restaurants. " "So closing on Mondays for dinner and opening on Saturday seems like a great idea so far," he said. "And moving the brunch from the Reliable Source to the Fourth Estate also seems like a great idea.

"After a slow start it seems like the regulars are more accepting of this \Box change as well. This change will increase revenue and reduce losses while \Box giving members new ways to enjoy their Club." \Box

The Board met in executive session to vote on the selection for this year's Fourth Estate Award.

NEW BUSINESS: NPC SCHOLARSHIP AWARD

The Board approved the Scholarship Committee's recommendation, as presented by Sylvia Smith, to name Viviana Benjumea of Elmhurst, New York, as the 2009 winner of the Club's Ellen Masin Persina Scholarship for Diversity in Journalism. Ms. Benjumea, who hopes to become a foreign correspondent for a major newspaper or TV network, will receive \$5,000 a year for four years toward her university education.

The Board approved Monday, June 22, as the date for the next BOG meeting.

The May 18 meeting was adjourned at 10 pm.
